
**Product information, including uses/applications and source(s) of imports:**

2,4-Dichloroaniline is a synthetic organic chemical used in the manufacture of a harvest aid defoliant for cotton. U.S. imports of this chemical are primarily from Germany, and Bayer CropScience is the principle importer. There are no known domestic producers of the chemical. Several companies market similar products in the U.S. that compete with this chemical.

There is already an existing duty suspension on this chemical under heading 9902.01.82 through December 31, 2006. The Commission suggests that this bill be re-written to amend heading 9902.01.82 by striking the effective date and inserting "12/31/2008" in lieu thereof.

<sup>3</sup> The Commission may express an opinion on the HTS classification of a product to facilitate consideration of the bill. However, by law, only the U.S. Customs Service is authorized to issue a binding ruling on this matter. The Commission believes that the U.S. Customs Service should be consulted prior to enactment of the bill.

To suspend temporarily the duty on 2,4-Dichloroaniline.

1 *Be it enacted by the Senate and House of Representa-*  
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. 2,4-DICHLOROANILINE.**

4 (a) IN GENERAL.—Subchapter II of chapter 99 of  
5 the Harmonized Tariff Schedule of the United States is  
6 amended by inserting in numerical sequence the following  
7 new heading:

“	9902.05.74	2,4-Dichloroaniline (CAS No. 554-00-7) (provided for in subheading 2921.42.18) ..	Free	No change	No change	On or before 12/31/2008	”.

8 (b) EFFECTIVE DATE.—The amendment made by
