Nature of bill: Temporary duty suspension through 12/31/2008.

Suggested article description(s) for enactment (including appropriate HTS subheading(s)):

Cyano(3-phenoxyphenyl)methyl 2,2-dimethyl-3-(1,2,2,2-tetrabromoethyl)-cyclopropanecarboxylate
(Tralomethrin) (CAS No. 66841-25-6) (provided for in subheading 2926.90.30)

Product information, including uses/applications and source(s) of imports:

The product, commonly known as Tralomethrin, is a synthetic organic chemical used as an insecticide for most flying and crawling insects such as mosquitoes, flies, cockroaches, ants, and termites. Valent USA imports the product from France.

Technical comments:³

The Commission notes that HTS heading 9902.01.52 currently provides a temporary duty suspension for Tralomethrin, either in bulk or with application adjuvants. The Commission suggests that the new duty suspension be enacted using this heading number. This could be accomplished by deleting heading 9902.01.52, and by using that heading number for the new duty suspension in this bill.⁴ The Commission suggests that the article description on page 1 of this report be used in the proposed new heading because it contains the correct HTS subheading (i.e., 2926.90.30) as well as the common pesticide name in parentheses.

³ The Commission may express an opinion on the HTS classification of a product to facilitate consideration of the bill. However, by law, only the U.S. Customs Service is authorized to issue a binding ruling on this matter. The Commission believes that the U.S. Customs Service should be consulted prior to enactment of the bill.

⁴ Specifically, line 6 of the bill could be amended to read “. . .amended by striking heading 9902.01.52 and inserting in lieu thereof the following. . .”. In addition, the heading number used in the bill, 9902.06.16, should be deleted and replaced with 9902.01.52.

3 **SECTION 1. TRALEMETHRIN.**

4 (a) IN GENERAL.—Subchapter II of chapter 99 of
5 the Harmonized Tariff Schedule of the United States is
6 amended by inserting in numerical sequence the following
7 new heading:
