**Bill No. and sponsor:** H.R. 2543 (Mr. Kuhl).

**Proponent name, location:** Corning, Inc., Corning, NY.

**Other bills on product (109<sup>th</sup> Congress only):** None.

**Nature of bill:** Extension of existing temporary duty suspension through Dec. 31, 2009.

**Retroactive effect:** None.

**Suggested article description(s) for enactment (including appropriate HTS subheading(s)):**

The bill should amend the expiration date shown in existing HTS heading 9902.04.33 rather than enact a new provision, and the effective periods of the two provisions would overlap.

**Product information, including uses/applications and source(s) of imports:**


The subject stoppers, lids, and other closures that are made of the specified low expansion glass are used as closures for glass containers in laboratory, hygienic, or pharmaceutical applications. This low expansion glassware is heat resistant and must be produced by automatic machines. The principal sources of U.S. imports under subheading 7010.20.20 are Mexico, China, France, and Austria, and under subheading 7010.20.30, Germany, China, and Italy.

**Technical comments:<sup>3</sup>**

It is suggested that the bill be amended to conform with other bills renewing existing duty suspensions or reductions, so that it would merely amend the expiration date as intended rather than create a duplicate heading with an effective period overlapping the existing provision. No changes in the existing heading's article description are suggested, because no problems in its scope or administration are known.

<sup>3</sup> The Commission may express an opinion on the HTS classification of a product to facilitate consideration of the bill. However, by law, only the U.S. Customs Service is authorized to issue a binding ruling on this matter. The Commission believes that the U.S. Customs Service should be consulted prior to enactment of the bill.

## A BILL

To suspend temporarily the duty on stoppers, lids, and other closures.

1 *Be it enacted by the Senate and House of Representa-*  
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. STOPPERS, LIDS, AND OTHER CLOSURES.**

4 (a) IN GENERAL.—Subchapter II of chapter 99 of  
5 the Harmonized Tariff Schedule of the United States is  
6 amended by inserting in numerical sequence the following  
7 new heading:

“	9902.70.10	Stoppers, lids, and other closures of low expansion borosilicate glass or aluminoborosilicate glass, having a linear coefficient of expansion not exceeding $3.3 \times 10^{-7}$ per Kelvin within a temperature range of 0 to 300° C, produced by automatic machine (provided for in subheading 7010.20.20) or produced by hand (provided for in subheading 7010.20.30) ..... 1           (b) **EFFECTIVE DATE.**—The amendment made by  
2 subsection (a) applies to goods entered, or withdrawn from  
3 warehouse for consumption, on or after the 15th day after
