Nature of bill: Extension of temporary duty suspension through December 31, 2008.

α,α,α -Trifluoro-2,6-dinitro-*N,N*-dipropyl-*p*-toluidine (Trifluralin) (CAS No. 1582-09-8) (provided for in subheading 2921.43.15).

Product information, including uses/applications and source(s) of imports:

Trifluralin is a synthetic organic chemical that is used as a preemergence herbicide to control annual broadleaf weeds in soybeans, cotton, turf, and numerous other crops. The imported bulk product is used to produce various formulations for sale in the domestic market. The subject product is imported from Italy.

The Commission suggests that the article description of HTS heading 9902.05.33 be amended to use the article description on page 1 of this report so that it conforms with the article description in HTS subheading 2921.43.15. The Commission also notes that H.R. 3229 proposes a duty reduction for the subject chemical.

³ The Commission may express an opinion on the HTS classification of a product to facilitate consideration of the bill. However, by law, only the U.S. Customs Service is authorized to issue a binding ruling on this matter. The Commission believes that the U.S. Customs Service should be consulted prior to enactment of the bill.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. TRIFLURALIN.**

4 (a) IN GENERAL.—Heading 9902.05.33 of the Har-
5 monized Tariff Schedule of the United States (relating to
6 α,α,α -Trifluoro-2,6-dinitro-*p*-toluidine) is amended by
7 striking “12/31/2006” and inserting “12/31/2008”.

8 (b) EFFECTIVE DATE.—The amendment made by
9 subsection (a) applies to goods entered, or withdrawn from
10 warehouse for consumption, on or after the 15th day after
11 the date of the enactment of this Act.
